USE INFORMATION

Remove all food and food packaging items before using this product. Scrape or brush away all heavy soil deposits on surface.

GENERAL SURFACE WHITENING



GENERAL SURFACE WHITENING

1. **RINSE** surface completely.
2. **APPLY** undiluted product onto surface to be whitened.
3. **SOAK** for 5 to 10 minutes.
4. **SCRUB** surface with brush.
5. **RINSE** surface completely with fresh potable water.

Note: If sanitation step is required, use a quality Franklin sanitizer after cleaning with **Butcher Block Whitener**.

FIRST AID:

If in eyes or on skin, immediately flush with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Get medical attention. Wash clothing before reuse.
